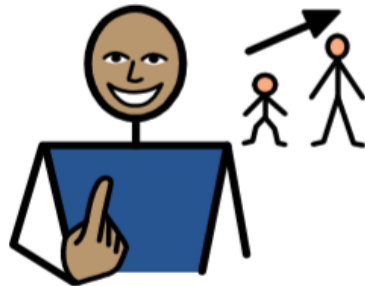

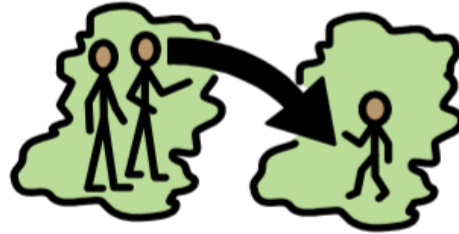

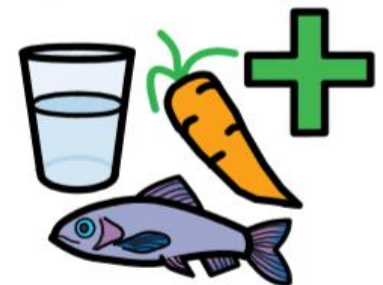
22 If I am a refugee, I have the same rights as children born in that country

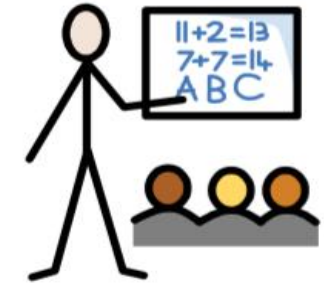
26 My family should get the money they need to help bring me up
